Metropolitan Emergency Services Board Radio Technical Operations Committee Meeting Notes November 15, 2017

<u>Members Present:</u> Peter Sauter, Robert Shogren, Ron Jansen, Chad LeVasseur, John Gundersen, Wendy Lynch, Nate Timm, Scott Haas, Rod Olson, Chuck Steier, Jake Thompson. Scott Gerber.

Call to Order:

Scott Haas called the meeting to order at 1:00 P.M.

Approval of Minutes

M/S/C Motion made by Gundersen to approve minutes from October 25, 2017. Timm seconded. Troy Tretter pointed out that the minutes reflected Tim Walsh was present. Pete Sauter was the member in attendance. Motion carried with correction noted.

Ron Jansen requested the agenda for November 15, 2017 be altered to include OTC request yesterday by FBI to add two regional talk groups in the metro for the Super Bowl.

M/S/C Motion made by Thompson to approve November 15, 2017 agenda with amended addition as Action Item #1. Gundersen seconded. Motion carried.

Agenda Items:

FBI request for additional talk groups (added to agenda)

FBI agent Rick Roeder; Minneapolis said they are currently participants of the state wide ARMER system. The FBI has two talk groups currently. They are requesting two regional additional talk groups to assist with Super Bowl 52. It is preferable to add these talk groups from Minneapolis downtown and the U of M.

Jansen said the OTC approved the request contingent upon the metro TOC approval to create them regionally. These will be new encrypted talkgroups level five sun-setted March 31, unless the FBI's plan amendment was approved at the OTC before then.

Jansen asked if they should be set up as fast-start or all-start. Roeder asked they be set up the same as their current talkgroups are. He will work with John Anderson before they are created.

M/S/C Motion made by Jansen to approve metro access talk groups. Gundersen seconded. Motion carried.

City of Edina participation Plan change

Tony Martin said the City of Edina is requesting a change to their Participation Plan. He said the level of access to the firewall provided by LOGIS will not need to be changed. The fiber is stained dark; dedicated for Edina. LOGIS is waving fees but there are some expenses for equipment paid for by Edina.

M/S/C Motion made by Gundersen to approve the Edina Participation plan. Gerber seconded. Motion carried.

Metro Standard 3.35.0 - National Weather Service

Jansen requested approval of changes made to Metro Standard 3.35.0. Nate Timm asked if the quantity of radios need to be listed by the National Weather Service. The first sentence listing quantity of radios will be changed to read Chanhassen Weather has a limited number of radios.

Tretter said this request for change to 3.35.0 National Weather Service ARMER Radio Operations has an effective date of January 31, 2018 and there will go before the MESB March 2018.

M/S/C Motion made by Timm to approve changes with above amendment made to Metro Standard 3.35.0, Timm seconded. Motion carried.

Metro Standard 3.28.1 - METEM Talkgroup

Dan Anderson said that the changes to Metro Standard 3.35.0 opens an opportunity to make changes to the METEM Talkgroup. This talkgroup will be used the ten days of the Super Bowl. Scott Haas said he would present discussion at the IPA group next month.

COML Packet - Leticia Cardenas, City of Minneapolis COML Packet - Deanna Olson, City of Minneapolis COML Packet - Jennifer Geiselhart, City of Minneapolis

M/S/C Motion made by Shogren approve all 3 COML Packets. Seconded by Gerber Motion carried.

Timm said the digital version of these packets includes a full incident action plan with some sensitive data. Tretter said those documents will be redacted from the packets, and removed from the MESB website since the COML packets are approved.

Lakes Region EMS Participation

Brian Galowitz; Lakes Region EMS Operations Manager said that Lakes Region EMS has been an ARMER subscriber since 2003. Lakes Region EMS currently has 51 radio IDs. They are requesting to increase number of IDs to 100. The OTC approved this change. The radios use ARMER while in Minnesota, and Polk County VHS while in Wisconsin. Administration and training for the radios is taking place.

M/S/C Motion made by Gundersen to approve Lakes Region EMS Participation Plan change. Shogren seconded. Motion carried.

Timm asked if the TOC needed to discuss about how LREMS is contracted with the MESB. Tretter stated he would talk with the MESB Executive Director about what should be done with the contact.

Haas would like some SUA detail from the state regarding what the long-term maintenance plan is for ARMER. Tretter said he would work with the state to discuss the planning progress.

Gundersen said the meeting yesterday approved the FBI and Lake Region EMS requests, additional ID requests from Wright and Swift Counties. and Dakota County microwave path request. There were also half a dozen state standards modifications.

There was a discussion about federal agency participation and where they fall organizationally under the federal hierarchy.

IPAWS – Haas reported that they are actively looking at the organization of the committee now that IPAWS falls under ECN rather than HESM. The committee reviewed a report from the accomplishments of the committee of the last year and the roadmap for the future of IPAWS.

Super Bowl 52 Communications Workgroup

Olson said there were Status Board requests that were put in place. LTAC1, STAC1 and METAC1 are left open. There were concerns from the TOC that there are not enough emergent talkgroups open for day to day incidents. The TOC chair requested someone from Minneapolis present on the communications plan for the Super Bowl at the next TOC.

Jansen said the request for METAC1-10 was for public safety only, and the request for METAC11E-12E was for members of the MAAG SWAT team.

M/S/C Motion made by Jansen to approve request. Timm seconded. Motion carried.

Haas announced the next meeting was scheduled for December 20th.

Dear Mr. Tretter:

The Eden Prairie Fire Department wants to install a mobile radio at the Eden Prairie Center. The radio will have only two Armer talk groups install and Transmit disabled. Those two talk groups would be EP-PTRL 1 and EP-FMAIN. Both talk groups are owned by Eden Prairie. This radio would resided in the Eden Prairie Center Mall Security office. Eden Prairie Police (EPPD) wants Mall security to know when incidents are happening at their location. Mall security operates off of the city owned 800 trunked system. EPPD has a patch that we use to listen to the Mall Security and allows EPPD to scan between both systems.

Eden Prairie Police Department will have the ultimate responsibility of insuring proper radio and legal usage. Mall Security has been using the city system for 20 years without incident. If the radio is used inappropriately or illegally the radio may be disconnected from Hennepin County Radio thus making the radio useless. If an investigation is conducted on any illegal usage the operator may be prosecuted and/or Mall Security loses it privilege to have the radio.

The Eden Prairie Police Department will continue to work and train Mall security personnel on its function and capabilities. Contacts are listed below
